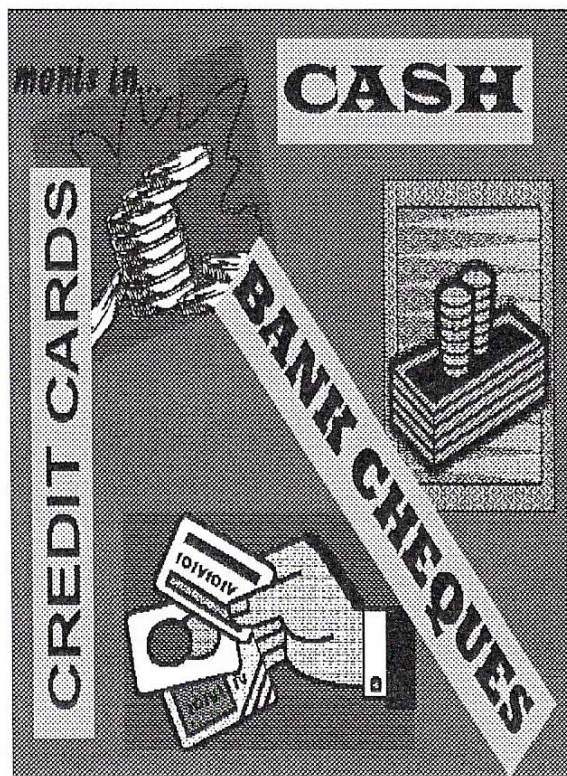

15.	For a copy of, or extract from any document, in addition to any fee for certifying the same, for each A4 sheet.	K2

16.	For a certificate issued by the Registrar, for which a fee is not elsewhere prescribed.	K25

For the submission of any document after the time specified in the Act in respect of that document (whether or not any other fee is payable and in addition to any other fee):- (a) if submitted not later than one month after the expiration of the time prescribed; and (b) if submitted later than one month after the expiration of the time prescribed.	K25 K100
18.	For the submission of any document for which a fee is not otherwise prescribed.	K25
19.	For an act done by the Registrar that he is required or authorised to do under the Act or the Regulation, and for which a fee is not elsewhere prescribed.	K50
20.	For any application or request for which a fee is not elsewhere prescribed.	K50
